ENROLLMENT AND RENEWAL

- ✦ A simple application is completed by customer and forwarded to ProGuard along with payment. Our application can be completed online at www.powderhornagency.com.
- ✦ Underground oil tank protection plans also require a passing tank tightness or soil boring test completed within the past 12 months.
- ✦ ProGuard Service Agreements are effective the first, fifteenth or last day of the month. Protection is never back-dated.

PROGRAM PROVISIONS

- ✦ ProGuard is transferable to an eligible new homeowner by completing one easy form.
- ✦ Customers must remain on oil heat in the event of a claim. Conversion to an alternate heat source, or conversion to gas will terminate or cancel the Accidental Release Service Agreement.
